CORONAVIRUS/COVID-19

ACTIVITY PARTICIPATION ASSUMPTION OF RISK, RELEASE, WAIVER, AND DISCHARGE

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. It is believed that an asymptomatic individual can be infected with and transmit COVID-19 without their knowledge.

Cavalli Creek Farms has put in place preventative measure recommended by the State of Florida and CDC to reduce the spread of COVID-19, however Cavalli Creek Farms cannot guarantee that you, your child(ren), your spouse, invitees or anyone else will not become exposed to or infected with COVID-19 as a result of participating in the event and/or activity at Cavalli Creek Farms. Participation in the event and/or activity could increase the risk of contracting COVID-19.

NOW, THEREFORE, in consideration of being permitted to participate in the event and/or program offered by Cavalli Creek Farms, I understand, acknowledge and agree to the following:

1. I will keep 6 feet social distancing all times, except with members of my household.
2. I will wash hands or use hand sanitizer frequently
3. I will voluntarily wear a mask when social distancing can not be achieved.
(Masks and hand sanitizer will be provided by Cavalli Creek Farms.)
4. I HEREBY affirm that I have not travelled from another country within 14 days of event and/or activity without abiding by the 14 day quarantine.
5. I HEREBY affirm that I have no symptoms associated with COVID-19.
6. I HEREBY affirm that I have not be in close contact with anyone known to have COVID-19.
7. I HEREBY consent to my temperature being obtained prior to entry.

I have independently evaluated and reviewed the risks of being exposed to or infected with COVID-19 and have determined to participate in Cavalli Creek Farms activity and/or event with full knowledge and acceptance of the risk. Fully understanding these risks, I, for myself, my child(ren), my spouse, my invitees, my legal representatives, heirs, and assigns, hereby agree to assume full responsibility and liability for the risk of bodily injury, illness, permanent disability, and/or death which my result from exposure to or infection with COVID-19 before, during, or after participating in the event and/or activity at Cavalli Creek Farms.

I, for myself, my child(ren), my spouse, my legal representative, heirs, assigns, hereby waive, release and discharge Cavalli Creek Farms, its officials, employees, volunteers, attorneys, vendors and agents from any and all liability to me, my child(ren), my spouse, my legal representative, heirs, and assigns, for any and all losses or damages resulting from bodily injury, illness, permanent disability and/or death, whether caused by negligence of Cavalli Creek Farms or it's officials, employees, volunteers, attorneys, vendors and agents or otherwise, which claims, losses, and demands arise during or result directly or indirectly from exposure to or infection with COVID-19 before, during or after participating in a Cavalli Creek Farms event and/or activity.

I also acknowledge that in the event the State or local health department issues a mandatory "Stay at Home" order, or mandates the closure of certain programs and/or facilities, participant(s) will be entitled to a partial refund at the discretion of Cavalli Creek Farms.
